REQUEST UNDER THE OFFICIAL INFORMATION ACT 1982

Thank you for your request to the Guardians of New Zealand Superannuation ("**Guardians**"), the manager of the New Zealand Superannuation Fund ("**NZ Super Fund**", "**Fund**"), dated 21 October 2019 made pursuant to the Official Information Act 1982 ("**OIA**").

Your Request

You have requested information on the Fund's investments that relate to the company "G4S", specifically:

- Please provide me with the Super Fund's total financial year investment and capital holdings of the company G4S, as far back as records permit.
- Please provide me with the total investment and holdings in other investment funds, portfolios, pooled investments, and other related aggregate investment, which include G4S as an investment. Please provide this information as far back as records permit. If this is unmanageable, please provide me with the data relating to the current/most recent reporting period.

Our response

Details of the information we have identified as being within the scope of your requests are set out below.

We have performed an annual search of the portfolio holdings with regard to G4S. The most recent (current) holding is at the bottom. The dates we could find holdings were:
