REQUEST UNDER THE OFFICIAL INFORMATION ACT 1982

Thank you for your request dated 20 October 2016 made pursuant to the Official Information Act 1982 ("**OIA**").

Your request

You requested the most up-to-date figures of the Fund's total investment in companies directly involved in the production of fossil fuels, and what this represents as a percentage of total investments, to the same GICS criteria that we produced figures for you in 2014:

- Coal & Consumable Fuels
- Integrated Oil & Gas
- Oil & Gas Drilling
- Oil & Gas Exploration & Production.

As at 30 September 2016 we estimate that the Fund had NZ\$671 million invested in companies directly involved in the production of fossil fuels. This total comprises approximately 2% of the Fund's assets under management (pre-tax).

The total includes 183 unique securities (listed equity holdings and bonds) as per the GICs codes listed above (see Appendix 1 for a list of the securities), and investments in four unlisted external investment mandates.

Please note that the Fund will also have indirect exposure to companies involved in the production of fossil fuels through derivative products such as futures and total return swaps. The Fund may also have some limited indirect exposure through investments in pooled funds, although we noted that relevant pooled funds account for a very small percentage of assets under management. Most of our exposure to fossil fuels is via our global passive equity portfolio.

Measuring the Fund's exposure to fossil fuels

We utilise a normalised measure for the Fund's carbon footprint – tons of CO2e/\$M invested - as this enables comparisons with a benchmark, or between multiple portfolios, and over time, regardless of portfolio size or allocation to different assets.

As you are aware, in October 2016 we publicly announced our climate change strategy. Climate change affects more than a single sector and our strategy addresses risks and solutions across the portfolio.
